- 3. Peter Bentley advised the membership that he is pretty busy at the moment and can't commit to the club in a coaching capacity, but has completed a Mental health coaching cse and is qualified as a Mental Health champion. Peter offered his services to the club and the President warmly welcomed this offer and expressed the Club's desire to have him as a Mental Health Coach. The President asked Peter for further discussions and how we can utilise his offered skill sets.
- 4. Darren Rigg, the President of the Montmorency Football and netball Club expressed his gratitude and thanks to the Montmorency Cricket Club for the level of support and cooperation over the last 12 months. Darren wished to pass on his thanks from MNFC where joint ventures for ground and facility improvements were entered into collaboratively between the clubs. Darren stated that with the joint financial support and co-operation, the facility at Para Rd had benefited both clubs seeing great improvements, with all members enjoying the benefits of the improved facilities. He expressed that he would like to further build on the close relationship between MCC and MNFC over the next 12 months in the same spirit of co-operation to further improve the facilities for both clubs..
