## **3. Acceptance of Minutes of AGM's May 2018 and May 2019**

## **4. President's Report**

1. On-field, was a challenging experience due to Montmorency Park North Oval being redeveloped therefore, loosing the use of the ground and nets for the season but on a positive, the new re-positioned pitch at Central Park, was greatly welcomed.
2. With respect to loss of our home ground & nets, there was the understanding of the bigger picture of having the best new playing surface going around and fantastic new nets, for Season 2020/21 onwards, so our coaches, players, parents and supporters got on board with training at Anthony Beale Reserve, Elder Street Reserve, Simms Road & once again, Streeton Primary School, together with Anthony Beale East being a replacement match day venue.
3. This Season, we saw fantastic participation across the club, fielding 5 Senior Teams (Money Shield, B Grade, E Grade, G1 Grade & G3 Grade), senior team in the NRT20, 1 Vets Team (Vets B), 10 Junior Teams (U18 Blue, U18 Teal, U16 Blue, U14 Blue, U14. Yellow, U12 Blue, U12 Red B, U12 Yellow & 2 x U10 Yellow Group B) and 40 girls andboys in the Blaster Programs. We saw some awesome team and individual results over the journey, with Money Shield just missing the finals by a game, E Grade missing finals by percentage, G1 Grade making the Semi, the Vets making the Semi, U16 Blue making the Semi, U14 Blue missing the Finals by a game, U12 Blue making the Semi, U12 Red B PREMIERS, U12 Yellow missing the Finals by a game & Ruwi making the DVCA Money Shield Team of

the Season & 4th in the DVCA John Gleeson Medal with 13 Votes.

Given the challenges we faced with our training facilities, overall, we saw improved Team performances across the board and believe this is our springboard for more team success in Season 202/21, especially with the use of the redeveloped Montmorency Park North Oval and the new Multi-Purpose Nets.

5. The President took the opportunity to sincerely thank our Senior Coach Chris Daw, training assistant's Bruce Norton & Wes Trotter, together with Senior Captains Jack Taylor, Jack Harrison, Shaun O'Brien, Josh Sedgwick, Ned Laurie & Adam Plant for the time and dedication with our playing list, Junior Coaches & Team Managers Jason Gaunt, Sean Watson, Wayne Norton, Steve Siede, Andy Coley, Trevor Williams, Kelly Williams, Jim Glover.

6. The President extended gratitude for the time and effort given by outgoing Committee members (John Bunn, Adrian Craze, Deepak Panthania, John O'Brien) and the tireless efforts they had put in over the previous season.

## **5. Treasurer's Report**

1. The Treasurer thanked the President and all the committee for their support in the previous season. The Treasurer advised that should he be re-elected it would be his last season and in all likelihood would not run again for the following season.
2. The Treasurer reported the club financial situation was severely impacted by grounds and facilities re-development resulting in a down turn in trade added with advent of COVID. This would have been more than likely negated at the tail end of the season we would have made a profit by season's end. Reported trading loss of \$3932.81. This included contributions to \$4.5K to the awning at Simms Rd, purchase of patio heaters for the club and desperately needed new BBQs.
3. The Treasurer voiced concern that due to COVID the season may be shortened which may also affect this season's revenue. with that said the Club is in a healthy financial position with a balance of \$33K in the accounts.
